### **1. INTRODUCTION**

Horn of Africa Services (“Owner”) is seeking proposals from qualified, licensed, bonded, and insured general contractors to perform **full demolition services** for the structure located at **11205 12th Ave SW, Seattle, WA 98146**.

The selected contractor will be responsible for providing all labor, materials, equipment, permits, and supervision necessary to safely and completely demolish the existing building, remove debris, and prepare the site in accordance with all applicable regulations. The project must successfully pass all required demolition inspections.

### **2. PROJECT OVERVIEW**

**Project Type:** Full building demolition to satisfy permit **Demo26-0006**.

### **3. SCOPE OF WORK**

The contractor shall provide a complete, turnkey demolition project, including:

- Coordination and verification of **utility disconnections**



- Coordination of **hazardous materials assessment or abatement** (if required)
- **Full demolition** of the structure and safe removal of all debris
- **Transportation and disposal** of materials in compliance with all laws
- **Site grading and stabilization** after demolition
- Completion of all required inspections and obtaining final approval

#### 4. CONTRACTOR QUALIFICATIONS

Contractors submitting proposals must meet the following minimum qualifications:

- Valid **Washington State Contractor License**
- Demonstrated experience with **similar demolition projects**
- Compliance with **OSHA safety standards**
- Contractor must be **bonded and insured**
- Ability to meet project schedule and inspection requirements

#### 5. INSURANCE & BONDING REQUIREMENTS

The selected contractor must provide proof of the following minimum coverage and bonding:

- **General Liability Insurance:** \$1,000,000 minimum
- **Performance Bond:** Required for the full contract amount
- **Payment Bond:** Required for the full contract amount

Proof of bonding capacity must be included in the proposal.

#### 6. LEGAL COMPLIANCE & DISPOSAL REQUIREMENTS

The contractor must comply with **all applicable local, county, and state laws, regulations, and ordinances** throughout the duration of the project. This includes demolition standards, environmental regulations, safety requirements, and waste-handling rules.

Upon completion of the demolition, the contractor is responsible for ensuring that **all debris, materials, and waste are fully removed from the site and disposed of at approved facilities** in accordance with **City of Seattle** and **King County** ordinances.

The Owner may request documentation verifying proper disposal.

- **Company Profile:** Background, qualifications, and key personnel
- **Project Approach:** Methodology, safety plan, and demolition strategy
- **Proposed Schedule:** Start date, timeline, and completion plan
- **Cost Breakdown:** Detailed pricing for all phases of work
- **References:** At least two recent demolition project references
- **Proof of Insurance and Bonding Capacity**

## 9. PAYMENT TERMS

- **45%** of the contract amount will be paid **at project start**, after contract execution. ● The remaining **55%** will be paid **only after King County has approved the demolition work** and all required inspections have been successfully passed.

The contractor must provide any documentation required by the county to verify compliance and completion before final payment is released.
